The Foreign Direct Investment (FDI) Survey collects financial information relating to direct investment in the UK by enterprises located abroad (inward FDI) and to direct investment abroad by enterprises located in the UK (outward FDI). In either scenario the foreign investment must be at least 10% of the ordinary shares or voting power.
